Selection process criteria	Curriculum vitae assessment; applicant's individual work plan assessment.
Deadline for selection process start date	A maximum of 15 (fifteen) days from closing date of application submissions. The selection process start date shall be posted on the website pos.direito.ufmg.br
Deadline for appointment of selected applicants	Up to 18 (eighteen) months from the publication date of the Final Result Notice; no extension allowed.
Duration of work contract	1 (one) year (Brazilian applicants) or 2 (two) years (foreign applicants), under the terms of item 9 of the General Terms and Conditions for the Selection of Visiting Professors.
